
Examples of significant engagements include:

- In Myanmar, advising a lender on the construction of a major international pipeline for an offshore drilling project (ongoing).
- In Myanmar and Cambodia, advising L'Oréal on customs duties, retail outlets, ASEAN free trade agreement implications, implications of ATIGA and tax structure of supply chain through various ASEAN states (advice on market entry, distribution, licensing for retail activity, tax implications of supply model).
- In Cambodia, advising JSM Indochina Property in the establishment, listing and winding up of a USD 220 million property fund on the Alternative Investment Market of the London Stock Exchange.
- In Cambodia, the Lao PDR and Thailand, advising a leading Singaporean Telecommunications Company as the purchaser
